Extended Travel — 10 to 25 miles	Starting at \$65

I-9 VERIFICATION — AUTHORIZED REPRESENTATIVE SERVICES

Single I-9 Verification <i>Travel fee additional — employer designation required</i>	\$35 per verification
Business Account / Bulk (5+ per month) <i>Priority scheduling + net-15 invoicing</i>	Contact for quote

APOSTILLE PREPARATION SERVICES

Standard Apostille Prep — Mail Submission <i>+ \$15 SOS fee + \$3–\$5 county fee per document</i>	\$75 service fee
Rush Apostille — In-Person Austin Submission <i>+ \$15 SOS fee + \$3–\$5 county fee — same-day processing, travel fee discussed</i>	\$150 service fee
Multiple Documents (3 or more) <i>Discounted service fee for document bundles</i>	Contact for quote

State and county fees passed through at cost. Apostilles issued by Texas Secretary of State only.
